Us Pawehleschanu tahs Keiseriffas Gohdibas ta Patwaldineeka wiffas Kreewu Walsts, ta Keiseriffa Lehrpatas Kreis=Teefa Sluddina :

Das Obrists, Teelskungs Peter Baron von Uexküll, Linnamâggi-muischas Dsintskungs, ar teem Werromuischas fainneekem, Peter Waggul un Peter Môtshârk, un ar to Terwenmuischas fainneeku, Hindrik Hein, tannl 20tâ deenâ Oktober-mehnesi 1834tâ gaddâ weenu Kuntrakti irr ustaisijis, un to paschu schai Keiseriffai Kreis=Teefai par apstiprinaschanu nodewis. Pehz scho Kuntrakti tee peeminneti fainneeki — Peter Waggul, Peter Môtshârk un Hindrik Hein — to pee Linnamâggi-muischas (Werroës Kreifê un Anzenes Wasnizas=Drandsê) peederrigu Zeematu, Murra=Zalla, kas 21 Dahlberus leels, par diwicuhstoscheem un astonfints Rubleem pappihra-naudas (2800 Rubel Banko=Assignmenten) par dsintu fewim irr nopitkuschi. Kad nu til labbi tas pahrdewejs, fâ arridsan tee pirzeji, luhguschi, scho Kuntrakti, — fâ Widsemnes semneeku Likkumi S. 55. to pawehl, — Sluddinaht, un schi Kreis=Teefa scho luhgfschanu peenehmufi; — tad zaur scho Sluddinaschanu wiffi tee, kam prett scho Kuntrakti kas buhtu ja-runna, scheitan tohp usfaukti: eelfsch weena gadda un feschu neddefu laika, no appakfschraftitas deenas, pee tahs

Tas Leelskungs, George Baron von Laudon, ar to pee Jaun-Kirris-muischas peerakstihu fainneeku, Jahn Meiren, tannî 19tâ deenâ September-mehneft 1832trâ gaddâ weenu Kuntrakti ustaisijis, prohti: Tas peeminnehts fainneeks, Jahn Meiren, to pee Wohlfahrtslinde (Zehses Kreise un Schwes Basnizas-Draudse) peederrigu Zeematu, Jaun-Leize, kas 18 Dahl-jerus leels, ar wiffahm ehkahn, tihrumem, mescha-semmi, dahrseem, pta-wahm un gannibahm, tà kâ winna rohbeschi taggadin nosihmeti, par diwisimts Rubleem sudraba-naudâ, few par dsimtu un ihpafchu, no Jurgeem 1833schâ gaddâ, nopirzis irr. Kad nu tik labbi tas pirzejs, kâ arridsan tas pahrdewejs, luhgufchi, fcho Kuntrakti, — kâ Widsemnes semneeku Likkumi §. 55. to pawehl, — fluddinagt; — tad zaur fcho fluddinaschanu wiffi tee, kam prett to Kuntrakti kas buhtu ja-runna, scheinan tohp usfaukti: eeksch weena gaddâ un feschu neddeku laifa, no appakfchraftitas deenas, pee tahs Keiseriffas Zehses Kreis-Zeefas peeteiktees; ar to peekohdinaschanu: ka pehz pagahjufchu Termina-laiku neweens wairs ar sawahm prettirunnaschanahm ne taps pee-

Kad tas pee Luggufcha-muischas peederrigs puifis, Jurris Grimpe, kas sagschanas deht appakfch Teefas stahweja, preeksch 8 neddelahm aisbehdsis, un wehl naw at-pakkal nahzis; tad wiffi tee, kam lahda sinna par to irr, fur schis Jurris Grimpe taggadin dsihwo, tohp usaizinati: to paschu fanemt un appakfch ap-wakteschanas us winna dsimteni aisfuhriht.

N o s i h m e f c h a n a: Jurris Grimpe irr 18 gaddus wejs, no smalka auguma, $4\frac{2}{3}$ pehdas garsch, ar sillahm azzim un tumfschi dselte-neem matteem.
