No taks Keiserifkas Kihgas Kreis-Teefas tohp sinname darrihts: ka tas Rohpmannis Johann Jürgensen no Kihgas, kam taggad ta Bullesmuifcha peederr, no ta turpat dshwodama fainneeka Martin Seemel wiffas winna mahjas-ehkas — bes piirs un fehka, fo schis fainneeks wehl warr aiswest, — par weenu fints un peejdesmit Rubleem Sudraba-Naudas irr pirzis. Zadeht zaur scho fluddinafchanu wiffi tohp usfauktî: kam prett schahs pahrdohfchanas kahda leeta pehz taifnibas buhtu pretti jarunna, un kam pee schahs mantas kahda praffifchana buhtu, lai tee peeteizahs, no taks appafschâ rakstias deenas, reefsch to laifu weena gadda un feschu neddelu, ar sawahm praffifchanahm, pee taks Kihgas pirmas Draudses-Teefas; jo zittadi tee wairs ne taps klaufiti, un wiffa ta nauda, kas wehl no teem 150 Rubleem irr atlikta, tam fainneekam Seemel taps ismaksata.

to spreedumu wehl naw peepildijis, un kã ta Raiwesmuishas Waldifchana ar
 luhgfschanu irr meklejis: ka ta, no wiinna Fihlã dohta bisse, ta pãrrada deht
 pahrdohtha taptu; — tad nu tas Eduard Schröder zaur scho fluddinaschanu teef

 Behrsaunes nomirris irr. Tadeht nu, ka wiinna mantineeki naw sinnami, wiffi
 zaur scho fluddinaschanu tohp usfaukti: kam pee wiinna masas atlikras mantas
 kahda taifna praffifchana buhtu, lai tee eeksch trim mehnescheem no appakschã
 rakstias deenas, tas irr lihds 9tu August sch. g., ar geldigahm parahdifchanahm
 pee schihs Keiserifkas ohras Draudses-Zeefas Zehses Kreise peeteizahs; jo pehz
